Development Review (22PLN-37) for the Holiday Inn Express hotel proposed to be located on a 2.74-acre portion of the parcel at 961 Plaza Drive. A tentative map was processed concurrently, approved by the planning commission at their December meeting, which will separate the hotel development from the remaining vacant 9.03 acres. The site is proposed to be developed with a ±42,000 square foot, 80-room hotel. The project is in the Central Business District (C-2) Zone, which allows hotel use as a permitted use contingent upon approval of a Development Review Permit (i.e. Design Review) for site plan and architectural building design in accordance with the city's Community Design Guidelines, and development standards of the City Municipal Code.


