The Firefighter Paramedic Recruit will be hired with the intention of sending this individual to a department paid for and accredited California state fire academy. The candidate must pass the academy and all state mandated firefighter testing as a condition of employment. The candidate will be required to work as a single role paramedic until the fire academy begins. Upon successful completion of the fire academy candidates will transition to a Firefighter Paramedic.

- Ability to pass a fire department sponsored accredited CA state fire academy and state mandated testing.
